## What information may be collected about you?

Personal information is any information which identifies you, or could be used to identify you, such as your name, contact details and interests. It may also include information about how you use our website or digital communications. We will only collect necessary personal data.

You can give us your personal information a number of ways, by entering a competition, promotion or contacting our consumer careline by phone or post.

This website is intended for use only by persons 16 years of age or older. By using the website, you represent that you are at least 16 years of age. If you are under 16, please do not provide us with any of your information unless you have the permission of your parent or guardian to do so. Please

The following types of personal information about you may be collected:

- When we contact with you or you take part in promotions or competitions, we may collect personal information you give us (i.e. your personal information to enable us to administer your participation in a promotion or competition).

# What do we use your personal information for?

Any personal information relating to you will be used by us in accordance with applicable data protection legislation and this Privacy Policy and only in line with any consent you have previously given.

The main uses of your personal information are:

- To respond to enquiries and ensure you get the best possible customer care.
- For management and administrative purposes.

We will only send you communications if you agree to receive them.

### Disclosure of personal information to third parties

We may share and disclose your personal information under the following circumstances:

- To our subsidiaries and affiliates:
- to contractors, service providers, and other third parties we use to support our business;
- to comply with law, a court order, or other legal process, or in connection with a legal investigation or a request for cooperation by a government entity;
- to enforce our Terms of Use, this Privacy Policy and any other applicable terms, conditions and other agreements;
- to protect our legal rights and interests, our business partners and third-party service providers, and our and their respective directors, officers, employees, representatives, and customers;
- to protect against fraud;
- in connection with a corporate transaction (such as a merger, financing, acquisition or dissolution) or proceeding involving the sale, transfer, divestiture, or disclosure of all or a portion of Premier Foods' business or assets. In the event of an insolvency, bankruptcy, or

receivership, personal information may also be transferred as a business asset, provided that the acquirer will assume the rights and obligations with respect to your personal information as described in this Privacy Policy.

## Storage and retention of your personal information

We know how important it is to protect and manage your personal information. We take appropriate security measures to help protect your personal information from accidental loss and from unauthorised access, use, alteration and disclosure.

Unfortunately, the transmission of information via the Internet is not completely secure. Although we do our best to protect your personal information, we cannot guarantee the security of your personal information transmitted to our Website. Any transmission of personal information is at your own risk. We are not responsible for circumvention of any privacy settings or security measures contained on the Website.

Premier Foods operates in the UK and we store most of our data within the European Union ("EU"). The information that we collect from you may be transferred to, and stored at, a destination outside the European Economic Area ("EEA"). It may also be processed by staff operating outside the EEA who work for us or for one of our customer services suppliers. While such information is outside of your country of residence, it is subject to the laws of the country in which it is held, and may be subject to disclosure to the governments, courts or law enforcement or regulatory agencies of such other country, pursuant to the laws of such country. Such staff may be engaged in, among other things, the fulfilment of your request and the provision of support services. #### **Data retention**

We will retain your personal information for only as long as it is necessary for the uses set out in this Privacy Policy and/or to meet legal and regulatory requirements. We will actively review the information we hold and securely erase personal information. Or in some cases if data is needed after this period for analytical, historical or other serious and legitimate business purposes, we will take appropriate measures to anonymise this data according to generally accepted practices.

#### **Your Rights**

# Updating your data and marketing preferences

Where we can provide data and action requests, we will do so free of charge. Subject to applicable laws, we will respond within approximately 30 days of receipt of your request.
